Terms and Conditions:

Payments – An initial reservation fee of \$ _____ is required with the signed contract to hold shooting dates and pre-production planning. Reservation fees are non-refundable. Balance of final fee is required upon completion of DVD (estimated time is approximately 4-6 weeks after initial shooting date). A \$ 35 fee will be assessed on all returned checks. Should a check be returned, shooting date may no longer be valid. The reserved date is the “Wedding Date” as stated on page 1 of contract.

Exclusive Rights – It is understood that Video Events is the exclusive official videographer retained to perform the services requested on this contract. The customer is acting as agents for all members of the party and guests and grants Video Events all rights for display, broadcast, exhibition, promotion, and advertising use of all images produced under this contract. All video masters and raw footage remain the exclusive property of Video Events. Raw footage can be purchased at an additional cost. One week after delivery of DVD raw footage may be bulk erased or archived.

Delivery of Finished Product – Finished product will be delivered or mailed to customer upon receipt of final payment

Reservation of Time and Date - This contract constitutes an order for one wedding videotape/DVD production. Upon execution of this contract and receipt of the reservation fee, Video Events will reserve the time and date agreed upon, and will make no other reservations for that time for the duration of the contract. Video Events agrees to use no substitutes or sub contractors in the fulfillment of the contract services except in the event of emergencies with the approval of the customer.

Restrictions – The customer is aware that restrictions imposed by others (e.g., photographer, church, reception hall, guest, etc.), and the constraints of the physical environment, safety, weather, and acts of God can affect the quality and extent of video coverage possible. Video Events guarantees coverage of all events only within the bounds of any restrictions and constraints of the physical environment, safety, weather and acts of God. Video Events can not guarantee coverage of outside events during inclement weather. The customer is responsible for obtaining all permissions and clearances, etc., and shelter from inclement weather and extreme temperatures are required by Video Events to operate.

Permissions – It is the responsibility of the customer to obtain permission to videotape at ceremony and reception locations.

Liability – Video Events takes the utmost care with respect to production, postproduction and delivery of the product (s). However, in the event that Video Events fails to comply with the terms of this contract, Video Events liability is limited to the reservation fee and any deposits paid by the client.

Warranties – Video Events makes no warranties express or implied, with respect to the work or property that is the subject matter of this contract.

Production and Editorial Control – Video Events is granted full production and editorial control by the customer regarding all aspects of the production and post production services for this event. If a particular segment is either not recorded, partially recorded, or not part of the edited master DVD, it is at the sole discretion of Video Events as exclusive producer of the video recording.

Special Instructions – If something occurred at the event that the client does not want to appear on the video/DVD's, the customer must instruct Video Events before editing begins.

Postponement/Cancellation – In the event of a postponement or cancellation of the wedding contract , any extra deposits will be returned, however the reservation Fee is non-refundable.

DVD compatibility – Video Events produces DVD's using the most compatible media for set-top players. Video Events is not responsible for incompatibility with the DVD's created and the customers DVD player. A sample DVD is available upon request.
